

## Checklist for becoming listed with DHS

Complete online ODHS Child Care Provider Orientation Part One – can be found here: occd.educadium.com
Relative Care:
Complete and mail or fax DHS Listing form 7494, including background checks and fingerprinting requirements for anyone in the home (where care is provided) over the age of 18 and common or frequent visitors. <a href="https://www.oregon.gov/DHS/ASSISTANCE/CHILD-CARE/Pages/Provider-Listing.aspx">https://www.oregon.gov/DHS/ASSISTANCE/CHILD-CARE/Pages/Provider-Listing.aspx</a> Background checks are done through the Oregon Central Background Registry. <a href="https://www.oregon.gov/delc/providers/pages/cbr.aspx">https://www.oregon.gov/delc/providers/pages/cbr.aspx</a> After the application is processed and approved by ODHS, you will receive a letter stating you have 90 days to take the second part of the Orientation class.

Non-Relative Care:

Attend training for Adult & Pediatric CPR and First Aid
Complete and mail or fax ODHS Listing form 7494, including background checks and fingerprinting requirements for anyone in the home over the age of 18 and common or frequent visitors. After the application is processed and approved by ODHS, you will receive a letter stating you have 90 days to take an Orientation class (see link above).
Attend the ODHS Child Care Provider Orientation Part Two training through CCRN

## **Ongoing Training Requirements**

## **Annual Health and Safety Training**

Required for: All license exempt providers who are <u>not related</u> to all children in their care. This training is not required if you are a great-grandparent, grandparent, aunt, uncle or sibling not living in the home of the child.

What is required: Every year, child care providers must take a Health and Safety training recognized by the Oregon Center for Career Development in Childhood Care and Education (OCCD). A minimum of 1 hour is required.

## Additional training: 6 hours every 2 years

Required for: All license exempt providers who are <u>not related</u> to all children in their care. This training is not required if you are a great-grandparent, grandparent, aunt, uncle or sibling not living in the home of the child.

What is required: Six hours of additional trainings are needed in each two-year period including:

Two hours in human growth and development (HGD)

Two hours in understanding and guiding behavior (UGB)

Two hours in a core knowledge category of the provider or staff's choice
